### Cllr. Dumanske

 Reported that D.Hopkins, Welder, will be coming on February 11, 2022 to fix the garbage cage gates.

## Reeve Anderson

- Discussed whether plows should jump around the RM and plow bus routes first after a storm or not. Council was not in favour of this.
- Council decided that they should finish plowing the roads in one ward before moving on to the next one.
- Reported that ODK Engineering is waiting to find out which RMs are going to commit to a new regional dump.

#### 3. Satellite Communicator Radios/Phones

Discussed Satellite Radios/Phones for the graders.

#### **RESOLUTION NO. 24-22**

BE IT RESOLVED THAT the Council of the Rural Municipality of Alonsa authorize to purchase two (2) Satellite Communicator Radios/Phones for the grader operators to have in the event of an emergency when they are out of cell service areas while working on RM Roads. For the amount up to \$1,200.00 to purchase and \$35.00 per month for twelve months a year, for the monthly plan.
