2. CAO & Council Reports

CAO Dumanske

 Reported that the office has been assisting Ebb & Flow First Nation in trying to find out ownership of DESC A, B & C – 1731 in Bacon Ridge. We have had no success getting in touch with the correct department. Council says we cannot give permission to Ebb & Flow to use the land when it's not our land.

Cllr. Dayholos:

- Discussed the final grading for Beckville Beach;
- Commented that Glen is doing an excellent job grading.

Cllr. Dumanske:

- Discussed quote for sidewalk at the Amaranth Post Office. Council feels they should obtain a second quote;
- Reported that the sportsgrounds in Amaranth have finally been cut.

Cllr. Brown:

- Reported that the water is right down at the MB House Drain so the road w/culvert can be repaired anytime;
- Discussed that we need a better barricade at Rd 66W/Rd 118N;
- Discussed that he would like to check the sinkhole on Rd 66W before it's filled;
- Discussed a permanent berm/dyke along the Bluff Creek Drain but we need more information.

Cllr. Mailman:

- Reported that Foster Mulching has added a new large snow blower to his fleet of equipment;

- Suggested that Council look into the possibility of getting a smart TV or smart board for the Council Chambers, CAO to look into pricing.
