COTTAGE DEVELOPMENTS (LAKESIDE SETTLEMENTS)

With Cottaging/Camping Season just around the corner, this is a friendly reminder that if you own a lot in one of our five cottage developments you are only permitted to have a camper or tent on your lot if you have an approved building permit and you are actively constructing your cabin. PROPERTY TAXES

Please let the office know if your address has changed or if there are joint owners on a property and the tax bill is not going to the right person, we can correct that as well.

Change in ownership due to loss of a loved one whose name was on the title is NOT something our office can change. You will need to contact Land Titles directly to add or remove names. *Note: They will most likely require legal proof. Please call [1-844-737-5684](tel:1-844-737-5684)

This is the last reminder from this office: If you received a letter back in September 2022 regarding the possibility of your property going up for tax sale and you have not yet paid anything towards your property taxes, the next correspondence you receive will be from the company that the RM hires to look after their Tax Sales. There is no date set, but the tax sale will take place this fall. Once the hired company starts to correspond with you there will automatically be tax sale fees added onto your account.
