CAO Dumanske is to relay to Cllr. Roulette that we cannot legally close a road without a State of Emergency being declared or in a non-emergent situation, a Road Closure By-Law has to be passed which has to include a Public Hearing. CAO Dumanske is to relay the Council's support for this endeavour and that they have no objections to this intersection being a manned checkpoint.

Cllr. Turko inquired about the new locks for the fire hall. CAO Dumanske reported that she was in contact with a contractor who said he would come when he completed his current job.

## Landfill Committee - Reeve Anderson

Reeve Anderson reported that the Landfill Committee met to discuss our next steps regarding the regional landfill. Their suggestion to Council is to hire ODK Engineering to guide us through the next steps and to write the grant application for the Municipal Economic Development Infrastructure Program Grant.

#### 8.2 CAO & COUNCIL REPORTS

#### Cllr. Dumanske

- Inquired about the advertisement of the Amaranth Curling Rink.
- Asked if CAO Dumanske could create a Request for Proposal for the demolition of the old Amaranth School on Beach Road.
- Inquired about the Notices of Contravention regarding the Unsightly Properties in Amaranth. CAO Dumanske informed they are here but she hasn't had a chance to go through them with the By-Law Enforcement Officer.

## Cllr. Brown

- Reported that the lagoon area needs to be cleaned and reminded CAO Dumanske that there are vent pipes that need to be repaired. Council also requested that signs be ordered and posted on fences warning the public about the open lagoon.

## Cllr. Hopfner

- Inquired about north mowing. CAO Dumanske hasn't heard back from the contractor yet. Reeve Anderson volunteered to get in touch with him.
- Reported that the culvert work on Rorketon East has been completed
- Inquired about the Ranch Estates Road Tender. Council decided it would be best to ask for Requests for Proposals first.

## Cllr. Turko

- Road 69W WRL CAO Dumanske informed council that the south half of the mile that Cllr. Turko wants cleaned is actually a watershed drain. Council requested that we apply for the whole mile.
- Inquired about the culvert that was requested by K.Kien. CAO Dumanske informed that we are still waiting for a survey.
- Reported that a landowner has requested to purchase some culverts to make an approach wide. Diameter is not changing so so a WRL is not required. Also requested another culvert that will need Whitemud Watershed approval.

## Cllr. Stott

- Reported on more random garbage dumping.
- Inquired about survey at C.Anderson's problem area. CAO Dumanske reported that it's never been completed but she will get in touch with TTES.

# Reeve Anderson

- Inquired about meeting with Operators to discuss Tiered Road System and confirmed which Councillors would like 3 passes on their busier roads.
- Discussion amongst Council regarding washboard and how it needs to be cut out.
- Inquired about Appeal Hearing for missed camper removal objections. CAO informed date is September 27, 2023.
