Summary of Municipal Requirements:

- Mowing (FENCE TO FENCE) approximately 97.75 miles (Approximately 170+ hours) of roads in Ward 1 (map available from RM Office);
- Cutting to be started by August 1st and to be completed by October 15th;
- Tractor(s) and mower shall be equipped with a flashing amber lights;
- Contractor must be registered and be in good standing with the Worker’s Compensation Board;

To facilitate this, The Rural Municipality of Alonsa is seeking written proposals from owners/operators:

- Proposals will NOT be opened or acknowledge publicly. Proposals will be opened during an In-Camera Council Meeting, but decisions will not (cannot) be made In-Camera.

The contractor must supply proof of Workers Compensation and Liability Insurance.

Awarding of the Proposal may be subject to inspection of the machinery.

Council will terminate the contract if performance is unsatisfactory.

Council may reject proposals, waive defects, or accept any proposal which they may consider in the best interests of the Municipality.

Lowest or any tender not necessarily accepted.

Sealed proposals marked will be received until **March 26, 2024 by 4:00 P.M.**

The Rural Municipality may reject any offer not enclosed in an envelope, so addressed and marked.

The Rural Municipality may reject offers, waive defects, or accept any offer which they may consider in the best interest of the Municipality

- (a) The Municipality will endeavor to award the 2024 Municipal Ditch Mowing Tender or reject all offers within five days of the date on which they were opened. The successful bidder will be notified by phone and then by letter, mailed to the address shown on the offer, that his/her bid has been accepted and awarded.
- (b) A bidder may, after the expiration of five days from the opening of offers, request in writing or by fax the withdrawal of his offer. Such withdrawal of an offer will be considered effective on the receipt of the request by the Municipality. In the event that a bidder does not request the withdrawal of his/her offer, he/she will, upon its acceptance, be under the same obligations to enter 2024 Municipal Ditch Mowing Contract as he/she was prior to the expiration of the said five days. Bidders will automatically be relieved of any obligation to enter into a Mowing Contract with the Municipality if no award is made within 10 days of the date on which the offers were opened.

The original Offer Form on which the Contractor has placed his/her signature, duly witnessed or sealed, when approved by the Reeve and Chief Administrative Officer, will be the 2024 Municipal Ditch Mowing Contract.
