LIST OF CONTRACT REQUIREMENTS ON THE SECOND PAGE....

- 1. <u>Beginning when contract is awarded</u>: Village Clean-up. Loose garbage throughout the Village must be picked up. Garbage barrels must be emptied as necessary.
- 2. Grass must be cut and trimmed along ALL boulevards, frontages, streets and road allowances, including shoulders and ditches along Hwy #50, within the Village boundaries (map available). Maintenance on a regular basis to sustain an on-going well-groomed appearance. Trimming around all buildings is required on lots that you cut.
- **3.** Vacant (private) lots in the Village will require cutting on request of a LUD Committee Member or the RM Office Staff. Maximum charges for standard lots are \$30.00/lot.
- **4.** Rusk Memorial Park will require cutting & maintenance on a regular basis and trimming around the Memorial Stone at the entrance.
- 5. The War Memorial will require cutting & maintenance on a regular basis as well as trimming around everything included with the memorial.
- **6.** Maintenance of grass and trimming around buildings of Memorial Hall and Fire Hall on a regular basis.
- 7. New Horizon's property on a regular basis from April to June and August to October.
- Check Christmas Lights in the fall and replace any bulbs needed. Plug in Christmas Lights during the 1st week of December and unplug the 2nd week of January. <u>\$200.00</u> WILL BE HELD BACK UNTIL THIS PART OF THE JOB IS COMPLETE.
- **9.** Amaranth & Area Haven of Rest Cemetery Regular mowing of grass in cemetery and on surrounding road allowance. Hand trimming of grave sites, headstones and hedges along West-side of Cemetery. Report to LUD Committee Member if you have to clean-up any debris left over from a burial.
- **10.** Requests to Outside Contractor for PRIVATE GRASS CUTTING will not be covered under this contract. Cutting and collecting fees will be your own responsibility and the Committee would require that any private grass cutting to be done only after Village Maintenance is satisfactory.
- **11.** Reporting to LUD Committee Members any concerns or observations (tree-top trimming, hydro wires, vandalism, uncut lots on private properties, any irregularities and/or citizen complaints.
- **12.** There will be a start-up advance of ½ the monthly payment made available. After this advance, no more advances will be authorized.
- **13.** Empty garbage/recycling bins <u>through the winter</u> flat rate will be paid monthly that is not included in this contract.
